## **Executive Director's Report:**

- <u>COVID-19/Board Meetings</u> Executive Director, Joseph Capano, discussed that other directors and colleagues have begun meeting in person with the option to utilize ZOOM. Chairman Colao stated that it would be beneficial to finish the year applying this procedure, as we gauge the severity of the new COVID-19 variant.
