- Write off Uncollected Rent: Walter Mulvaney Long standing tenant, Walter Mulvaney, passed away last year. With no next of kin on file, and no security deposit, the Cliffside Park Housing Authority must write off one month of uncollected rent in the amount of \$354.00 for FYE 3/31/2022.
- 215 Riverview Avenue Acquisition Mr. Capano explained that, after visiting the building and meeting with some of the tenants, the building is in good shape and the tenants are receptive to the Cliffside Park Housing Authority becoming their landlord. He thanked Bill Katchen, Frank Borin and the Team at Decotiis, Fitzpatrick, Cole and Gibln, and the Board of Commissioners for their help and hard work throughout this endeavor. Mr. Capano introduced Frank Borin, Special Counsel on this project for an overview of events. Mr. Borin opened by congratulating the Board on the acquisition. He followed by explaining that the process took longer than anticipated due to the type of closeout causing a delay with HUD's approval.
