Joseph Capano, Executive Director, asked if there were any corrections, additions, or deletions to the minutes of the June 6, 2022 regular meeting. Executive Director's Report:

- RFP's Received for Services RFP Results for: Boiler Maintenance Services, Electrical Maintenance Service, Plumbing Maintenance Services, Painting in Apartments as Needed, and Countertops and Backsplashes as Needed.
- 2017 Lawsuit with HUD Mr. Capano indicated, that in 2017, HUD garnished the Cliffside Park Housing Authority's operating reserve. Bill Katchen, CPA, advised the finance committee of a National Lawsuit on behalf of Housing Authorities in attempt to recoup what was garnished from them. Mr. Capano explained that, after several appeals from the Government, reimbursements were issued, and the Cliffside Park Housing Authority has received over \$700,000.00 back. The Cliffside Park Housing Authority will hold on to this money; however, a letter of intent was sent to the owner of a five-unit building (232 Lincoln Cliffside Park, in hopes of converting it into Section-8 Housing.

<u>Chairman's Report</u> - Chairman Colao indicated that sending a letter a letter of intent to the owner of 232 Lincoln Avenue is not a new attempt at acquiring the property. The Cliffside Park Housing Authority has been reaching out to the owner prior to the acquisition of 215 Riverview Avenue. The Chairman explained that any opportunity that we are given to expand Section-8, and provide our voucher holders housing, we must take it, especially when we are awarded new money.

Finance Committee - Bill Katchen, CPA, had no formal report.

<u>Buildings and Grounds Committee</u> – There are currently two apartments being turned over. A preconstruction meeting was held last week in regard to the PAL Roof Replacement, and core drilling will begin there tomorrow, July 6, 2022.

<u>Personnel Committee</u> – Summer help is in the office, as well as maintenance, and projects are moving along. After eight years of working summers, Claire Mancini is training new summer hires in the office, and maintenance help are each teamed with a staff member.

Activity Center Report – Linda Phillips-Perez, Activity Center Coordinator, reported that summer trips and concerts are moving along with a Luau on the patio on July 15th, Farmers' Market on July 12th, two River Queen Luncheons, a Rod Stewart Tribute Trip, a Flea Market, and a Pennsylvania trip with a Riverboat and Flight 93 Tour. Linda indicated that booster shots are still being scheduled, however, the facility limits appointments to Tuesday afternoons. Mr. Capano and Ms. Phillips-Perez are currently looking into a Murder Mystery Dinner Fundraiser.
