Executive Director's Report:

- Housing Authority Update Much was accomplished this summer with Summer Help. All of the Administrative Offices files were purged, the Section 8 Waiting List was purged, as well. With Section 8 funding at 99%, and the waiting list recently purged, we may consider opening the waiting list within the next few months. Summer Help in the Maintenance Department accomplished many tasks as well, and we have two members until September 9, 2022.
- RFP's-Website/Fire Alarm Maintenance Envision Technology of Cliffside Park, NJ has submitted a proposal for Website Maintenance Services, and United Federated Systems of Totowa, NJ has submitted a proposal for Fire Alarm Maintenance. Both are two-year contracts.
- <u>Special Legal Counsel</u> As it is not customary for Housing Authority Attorneys to take part in Eviction Hearings, the Cliffside Park Housing Authority has sought Special Counsel. Executive Director, Joseph Capano, recommends that Terrence Corriston of Breslin & Breslin, P.A. assist the Cliffside Park Housing Authority with our tenant-landlord matters.
- <u>Brick Masonry Repairs</u> Bid results for the brick masonry repairs on the east side of the 500 Building have been recommended by LAN Associates, Cliffside Park Housing Authority Architect/Engineer and reviewed and approved by Frank Borin, Cliffside Park Housing Authority Attorney.

Video surveillance was installed at 215 Riverview Avenue, per the Joint Insurance Fund guidelines. The mailboxes at 215 Riverview Avenue were relocated to create two additional parking spaces and an area for signage. The tenants are grateful for the proactivity. Mr. Capano credited the maintenance staff for many of the improvements.

<u>Personnel Committee</u> – One of the Senior Transport Drivers unexpectedly and suddenly resigned. We are currently looking for a driver, and have placed a notice on our website.

<u>Activity Center Report</u> – Mr. Capano reported that the Senior Activity Center has been very busy. The End of Summer BBQ Event will be held on September 23 and will feature a ribbon cutting ceremony for 215 Riverview Avenue/Acquisition.
